RUM RIDGE OWNERS WHO RENT

Owner Info (7-27-24)

Set a maximum # of people allowed on the property. This prevents "reunions" where large numbers of people gather in one spot to socialize, even though they may not be sleeping there. You can monitor this by installing a webcam outside over the front door or the driveway.

Set a maximum number of guests based on beds/bedrooms. Your septic system is sized on this basis. Overflow may contaminate your water well and your neighbors.

Set a maximum # of vehicles/trailers, and make sure they are all parked in your own driveway.

Set a maximum number of pets (or no pets), and specify they must be leashed when outside. Pet cleanup requirements apply.

Speak to one or more of your nearest neighbors, and encourage them to contact you directly if there are any concerns.

Make arrangements for trash removal so that nothing is left outside on a non-pickup day. Trash cans should be stored inside the garage or shed. For pickup, trash must be in sealed trash bags placed in cans separated by recycle and redemption items. Recycle item bags must be placed in the blue recycle crates on the first Monday of each month. Trash cans and recycle crates should be placed at the established collection points on Rum Ridge Road Monday mornings by 11 am. and retrieved before sunset. Redemption items are not collected and must be disposed at approved locations. Non kitchen trash, comingled trash and trash in open bags will not be collected.

Provide ATV & Snowmobile trail access info to guests. Joy riding on Rum Ridge property is not permitted.

During the cold months, advise that guest vehicles should be equipped with winter tires and/or 4 wheel drive. There is very limited Roadside Assistance available.

Post a sign on the refrigerator with guest information.

As the property owner, Rum Ridge assigns you personally responsible for the actions of your guests.

Provide clear driving instructions to locate the rental location.

Snowmobiles may be ridden on the roads to access the trail on the end of Crows Corners Rd. or at the end of Loon Landing Rd. onto Lower Wilson Pond when ice conditions are safe. Joy-riding on Rum Ridge roads is prohibited.
